WHEREAS, the City Council of the City of Victorville, County of San Bernardino, State of California, and KB Home Coastal, Inc. 

As part of the obligation secured hereby and in addition to the face amount specified therefor, there shall be included costs and reasonable expenses and fees, including reasonable attorney's fees, incurred by City in successfully enforcing such obligation, all to be taxed as costs and included in any judgment rendered.


