THIS AMENDMENT (the “Amendment”) is made and entered in to this ____ day of _____ 2025, by and between the Victorville Water District, a County Water District and subsidiary district of the City of Victorville, organized and existing in the County of San Bernardino under and by virtue of the laws of the State of California (hereinafter referred to as “District”), and **Ferguson Enterprises, LLC, a Virginia Limited Liability Company**, hereinafter referred to as “Service Provider.” The District and the Service Provider are sometimes hereinafter referred to as a “Party” or and collectively referred to as the “Parties”.

Recitals

1. **WHEREAS**, the District has a General Services Provider Standard Agreement (hereinafter referred to as “Original Agreement”) with the Service Provider to provide **Neptune 360 Software**; and
2. **WHEREAS**, it is the desire of the Parties to issue Amendment One (1) to the Original Agreement to amend Section 3., Compensation to revise the total annual not to exceed sum from \$45,769.22 to \$250,533.00; Section 4., Proposal is amended to include additional services as set forth in the Service Provider’s revised Proposal; and Section 6., Term of the Agreement is amended to exercise Option 1 of 4, additional one-year periods, amending the term to commence November 1, 2024 and expire October 31, 2025; and
3. **NOW THEREFORE**, in consideration of the covenants, conditions, and promises contained herein and for such other good and valuable consideration, receipt of which is hereby acknowledged, the Parties are willing to amend the Original Agreement as stated below.

Contract Amendment

Section 3. – COMPENSATION – is amended as follows:

“The District shall pay a total sum not to exceed **Two Hundred Fifty Thousand Five Hundred Thirty-three and 00/100 Dollars (\$250,533.00)** for the services to be rendered by Service Provider pursuant to this Agreement, subject to the provisions of Section 4.”

Section 4. – PROPOSAL – is amended as follows:

“The District shall pay Service Provider, for those additional services set forth in Amendment 1, Service Provider’s Quote dated January 31, 2025, attached hereto as Exhibit A and hereby incorporated as part of this agreement by this reference.”

Section 6. – TERM OF AGREEMENT - is amended as follows:

“The District hereby amends the Term of Agreement to commence on November 1, 2024 (the “Commencement Date”) and expire on October 31, 2025 (the “Termination Date”).”

Except as amended herein, the terms and conditions of the Original Agreement and all previous amendments remain in full force and effect.
