RESOLUTION NO. SCLAA 25-005

A RESOLUTION OF THE GOVERNING BOARD OF THE SOUTHERN CALIFORNIA LOGISTICS AIRPORT AUTHORITY (“SCLAA”) ACCEPTING THE TRANSFER OF CITY-OWNED PROPERTIES AND AUTHORIZING THE SCLAA EXECUTIVE DIRECTOR TO ACCEPT DEEDS FOR SAID TRANSFER

RECITALS

WHEREAS, the City of Victorville (“**City**”) is the owner in fee simple of certain real property as described more specifically in Exhibit “A”, and hereinafter referred to as “**Properties**”; and

WHEREAS, under the Surplus Land Act (Government Code Sections 54220-54234, the “**Act**”), surplus land is land owned in fee simple for which a local agency’s governing body takes formal action at a regular public meeting declaring such land to be surplus and not necessary for a local agency’s use; and

WHEREAS, under the Act, land must be declared either “surplus land” or “exempt surplus land”, as supported by written findings, prior to a local agency disposing of said land; and

WHEREAS, Section 54221(f)(1)(D) of the Act, “exempt surplus land” includes land that is transferred to another local, state, or federal agency for the transferee agency’s use; and

WHEREAS, the Southern California Logistics Airport Authority (the “**SCLAA**”) is a joint powers agency duly formed and existing under the California Joint Exercise of Powers Act, Government Code Section 6500 *et seq.*; and

WHEREAS, the Southern California Logistics Rail Authority (the “**SCLRA**”), a former joint powers agency formed by the City, the SCLAA, and the former Victorville Redevelopment Agency, was created to facilitate the development of rail facilities and related improvements adjacent to the Southern California Logistics Airport (the “**Airport**”); and

WHEREAS, the City, in cooperation with and on behalf of the SCLRA and the SCLAA, previously initiated and completed the acquisition of the Properties, located immediately adjacent to the Airport, for the purposes of the development of rail facilities and related improvements planned at the Airport; and

WHEREAS, the Properties were acquired using revenue proceeds from SCLAA 2003 and 2005 Series Bond issuances, collectively the “**SCLAA Bonds**”, and the repayment of said bonds is an attributable to the SCLAA; and

WHEREAS, as a result of economic conditions beyond the control of the SCLRA as well as BNSF Railways’ decision to develop an intermodal facility in Barstow, the SCLRA was

dissolved and there is no need to pursue the development of rail facilities adjacent to the Airport; and

WHEREAS, given that the Properties were acquired using revenue from the SCLAA Bonds, the City desires to transfer the Properties to the SCLAA as a corrective action to ensure proper vesting and that the Properties are appropriately accounted for as a part of the assets of the SCLAA; and

WHEREAS, as the Properties are not necessary for municipal operations, at its meeting of March 4, 2025, the City Council of the City of Victorville declared the Properties as “exempt surplus land” pursuant to Section 54221(f)(1)(D) of the Act, made the required findings, and authorized transfer of the Properties to the SCLAA by adoption of Resolution No. 25-016; and

WHEREAS, the SCLAA desires to accept the transfer of the Properties (i) to ensure the continued use of same by the SCLAA; (ii) to enhance development opportunities for the SCLAA; (iii) to serve the vital and best interest of both the SCLAA and the City and the health, safety, and welfare of its residents; and (iv) in accord with the public purposes and provisions of applicable federal, state, and local laws and requirements; and

WHEREAS, pursuant to Section 15301 of the State of California Environmental Quality Act (“CEQA”) Guidelines, the transfer of the Properties is exempt from environmental review under CEQA because the transfer will result in a continuation of an existing facility involving no expansion of use, and any future development of the Properties will require separate environmental review.

NOW, THEREFORE, THE GOVERNING BOARD OF THE SOUTHERN CALIFORNIA LOGISTICS AIRPORT AUTHORITY DOES HEREBY RESOLVE, DECLARE, DETERMINE, AND ORDER AS FOLLOWS.

Section 1. Recitals.

That the foregoing Recitals are true and correct and together with any definitions set forth therein are incorporated into this Resolution by this reference.

Section 2. Transfer as a Corrective Action and for Common Benefit.

That the transfer of the Properties to the SCLAA is to serve as a corrective action to ensure proper vesting and appropriately account for the Properties as a part of the assets of the SCLAA. The SCLAA does hereby also find that the transfer of the Properties is for the common benefit because such transfer (i) will ensure the continued use of same by the SCLAA; (ii) will enhance development opportunities for the SCLAA and the Airport; (iii) serves the vital and best interest of both the SCLAA and the City and the health, safety, and welfare of its residents; and (iv) is in accord with the public purposes and provisions of applicable federal, state and local laws and requirements.

Section 3. Effect of Transfer and Assignment.

The SCLAA hereby accepts the transfer of the Properties from the City for its use; however, no transfer of the Properties shall occur until HCD fails to raise objection to City of Victorville Resolution No. 25-016 and at least thirty (30) days have elapsed following the date the City submits City of Victorville Resolution 25-016 to the HCD.

Section 4. Quit Claim Deeds/ Grant Deeds.

That the SCLAA Executive Director or his designee is hereby authorized and directed to accept in the name and on behalf of the SCLAA, one or more Quit Claim or Grant Deeds, in a form approved by the Executive Director (or designee) and the SCLAA's Counsel for the transfer of the Properties.

Section 5. Effective Date.

That this Resolution shall take effect immediately upon its adoption.

Section 6. Certification.

That the SCLAA Secretary shall certify to the passage and adoption of this resolution; shall enter the same in the book of original Resolutions of the SCLAA; and shall make a minute passage and adoption thereof in the records of the proceedings of the SCLAA, in the minutes of the meeting at which this Resolution is passed and adopted.
