**TERMINATION AND RELEASE OF DECLARATION OF COVENANTS, CONDITIONS
AND RESTRICTIONS AND
NOTICE OF AFFORDABILITY RESTRICTIONS ON TRANSFER OF PROPERTY**

PLEASE TAKE NOTICE THAT the City of Victorville, a Municipal Corporation (the "City") is the sole beneficiary of that certain Declaration of Covenants, Conditions, and Restrictions (CC&Rs) executed by the City of Victorville Economic Development Department on October 28, 2009 and recorded on November 6, 2009 as Instrument No. 2009-0484442 in the Official Records of San Bernardino County, California (the "Affordable Housing Restrictions"), upon that certain real property identified in the Affordable Housing Restrictions and described in the attached Exhibit A (the "Property"). The Affordable Housing Restrictions were recorded concurrently with the Notice of Affordability Restrictions on Transfer of Property, executed on October 28, 2009 by Economic Development Department and recorded on November 6, 2009 as Instrument No. 2009-0484443 in the Official Records of San Bernardino County, California (the "Notice of Affordability Restrictions on Transfer of Property").

Pursuant to the terms of the Affordable Housing Restrictions, the City shall execute a release of the encumbrances provided that the homeowner has repaid the Mortgage Assistance Program loan in full and remitted the accrued interest payment to the City of Victorville. As the preceding conditions have now been met, the City of Victorville hereby terminates the Affordable Housing Restrictions and forever releases the encumbrances of the Affordable Housing Restrictions from the Property. Accordingly, the Notice of Affordability Restrictions on Transfer of Property is also terminated and released.
