RESOLUTION NO. 25-018

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF VICTORVILLE AMENDING THE ANNUAL BUDGET FOR FISCAL YEAR 2024-2025; APPROVING ADDITIONAL REVENUE

WHEREAS, the City Manager of the City of Victorville (“City”) did heretofore submit to the City Council an estimate of expenditures and revenues of the City departments and offices, together with a proposed budget for fiscal year 2024-2025; and

WHEREAS, copies of said budget were prepared and distributed to the City Council and approved by the City Council on June 4, 2024, and have been available for inspection by the public in the office of the Victorville City Clerk; and

WHEREAS, the Southern California Logistics Airport Authority (“SCLAA”) is a joint powers agency duly formed and existing under the California Joint Exercise of Powers Act, California Government Code Section 6500 *et seq.*; and

WHEREAS, the Southern California Logistics Rail Authority (the “SCLRA”), a former joint powers agency formed by the City, the SCLAA, and the former Victorville Redevelopment Agency, was created to facilitate the development of rail facilities and related improvements adjacent to the Southern California Logistics Airport (the “Airport”); and

WHEREAS, the City, in cooperation with and on behalf of the SCLRA and the SCLAA, previously initiated and completed the acquisition of Assessor’s Parcel Number 0472-161-17, the “Property”, located immediately adjacent to the Airport for the purposes of the development of rail facilities and related improvements planned at the Airport; and

WHEREAS, the Property was acquired using City Road Development Impact Fees; and

WHEREAS, as a result of the economic conditions beyond the control of the SCLRA, as well as a BNSF Railways’ decision to develop an intermodal facility in Barstow, the SCLRA was dissolved and there is no need to pursue the development of rail facilities adjacent to the Airport; and

WHEREAS, given that the Property is adjacent to the Airport, and can serve the operations of the SCLAA, the SCLAA is desirous of acquiring the Property from the City and as such shall reimburse the City for all acquisition costs totaling \$2,222.19; and

WHEREAS, the need to amend the budget is necessary to recognize the increase in budget revenue.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF VICTORVILLE DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. That the annual budget for the fiscal year 2024-2025 for the City of Victorville be hereby amended to reflect an increase in budget revenue as shown below and as described in the corresponding agenda item dated March 4, 2025.

SECTION 2.
