


## ALPR Calendar Year End Totals (January - December 2024)






## ALPR Calendar Year Running Totals (January - December 2024)

### Quarterly ALPR Totals January 2024 - December 2024



### Case Summary Examples

**Summary 1** - ALPR hit on a stolen vehicle which was located in a nearby parking lot with the assistance of H80. A male was seen walking from the vehicle into Jack in the Box, and a short time later, the male along with another male were contacted and both admitted to driving the vehicle at different times over the past few days. The male explained that another male dropped off the vehicle several days prior, asking them to fix it, but he did not provide information on that subject. Both driver and passenger were arrested.

**Summary 2** - A stolen U-Haul truck was identified through ALPR. Deputies located the box truck on 7th and La Paz and initiated a traffic stop. The driver failed to yield and drove in opposing lanes of traffic and entered the I-15 freeway northbound using the I-15 NB offramp, driving on the opposite side of the roadway. Deputies aired the direction of travel and deputies located the truck on the I-15 NB offramp at Mojave Drive. A witness observed the suspect run from the truck into the Circle K on Mojave. The suspect was detained inside the store by deputies and video surveillance showed the driver as the one who stole the box truck earlier in the day.

**Summary 3** - Deputies located the stolen vehicle at a gas station and conducted a brief surveillance. When deputies attempted to contact the driver, he fled on foot from the deputies. After a short foot pursuit, he was taken into custody. A black BB gun was located inside of the vehicle.

**Summary 4** - Deputies got an ALPR hit on a stolen vehicle and conducted a traffic stop. 3 subjects were in the vehicle. The vehicle was purchased with counterfeit money. The driver was arrested for the theft and the passenger was arrested for a felony warrant.

**Summary 5** - Dispatch advised of an ALPR hit of a stolen Kia Soul near the intersection of Amargosa and La Mesa. Deputies located the vehicle traveling southbound I-15 near Oak Hills Road and initiated a traffic stop. The vehicle failed to yield, accelerated and led deputies on a pursuit. The vehicle reached speeds of 100mph and continued SB I-15, eventually exiting on University Parkway in San Bernardino. Deputies performed a PIT maneuver near the intersection of West College and N. State Street and the two occupants of the vehicle fled on foot. Both suspects were eventually detained without further incident and found to be juveniles. One juvenile was booked into Juvenile Hall and the other was released to his parents.

**Summary 6** - At the same time of an assault with a deadly weapon call, an ALPR came out for a stolen vehicle. Deputies located the vehicle which then immediately led them on a pursuit onto the I-15 freeway. The vehicle exited in Hesperia and pulled into an apartment complex with only one gated entrance. Two occupants fled on foot from the vehicle. Deputies chased on foot for approximately 3 miles before the driver was located along the aqueduct. The driver was found to be on parole for home invasion robbery and a loaded Glock was found on the floorboard of the car. Driver was arrested.

**Summary 7** - An ALPR hit was received on a stolen vehicle and when deputies attempted to stop it, a pursuit ensued. During the pursuit, the suspect nearly hit a police unit. The suspect fled on foot from the vehicle while it was still moving. Deputies established a perimeter and the suspect was located inside Doris Davies park. Driver was arrested.

**Summary 8** - Deputies responded to an ALPR hit out of Duarte. Deputies located the vehicle still mobile in the area. A felony traffic stop was conducted, and the driver was taken into custody without incident. He admitted to taking the vehicle from the R/O's front yard but stated he took it to fix it because he was a mechanic. The R/O had no idea who the driver was. The driver was arrested and his cat (which was in the car with him) was taken by animal control.

**Summary 9** - Deputies located a stolen vehicle that had been hitting ALPRs in the City all night. Vehicle failed to yield and led deputies on a 19-mile high-speed pursuit. The driver, a 17 year-old juvenile made his way around and entered the freeway southbound, exited Mojave, and went westbound, then north on HWY 395, passed Bear Valley, made a u-turn and a PIT maneuver was conducted at HWY 395/Bear Valley. After the first PIT by deputies, the driver continued and rammed a deputy's unit. Once the vehicle was disabled, he fled on foot into the desert. Deputies caught him quickly. The driver was successfully taken into custody.

**Summary 10** - Deputies located a stolen Kia after several ALPR hits throughout the day. The driver led deputies in a high-speed pursuit through several surface streets. The vehicle lost control and collided with a building and an electrical box. The vehicle caught fire. The driver was found to be a juvenile. He was jail checked and found to have a fracture on his right wrist due to the collision. Juvenile was treated at the hospital and then booked into juvenile hall.
