THIS AMENDMENT (the "Amendment") is made and entered in to this 10th day of November, 2020, by and between the City of Victorville, a municipal corporation, organized and existing in the County of San Bernardino under and by virtue of the laws of the State of California (hereinafter referred to as "City"), and **Keenan & Associates, a California corporation**, hereinafter referred to as "Consultant", City and Consultant are sometimes hereinafter referred to individually as a "Party" and collectively referred to as the "Parties".

Recitals

- 1. WHEREAS, the City has a Consultant/Professional Services Provider Agreement (hereinafter referred to as the "Original Agreement") with the Consultant to provide Property & Casualty Insurance Brokerage & Consulting Services; and
- 2. **WHEREAS**, it is the desire of the Parties to issue Amendment One to the Original Agreement to increase Section 3., Compensation by \$35,000.00, thereby amending the total annual not to exceed sum from \$15,000.00 to \$50,000.00; Section 4., Fee Schedule to include additional services as set forth in the Consultant's Proposal attached; and Section 6., Term of the Agreement to add an additional 12 months to the agreement, amending the term to expire June 30, 2022; and
- 3. **NOW THEREFORE,** in consideration of the covenants, conditions, and promises contained herein and for such other good and valuable consideration, receipt of which is hereby acknowledged, the Parties are willing to amend the Original Agreement as stated below.

Contract Amendment

Section 3. – COMPENSATION – is amended as follows:

"The City shall pay to Consultant an annual sum not to exceed **Fifty Thousand and 00/100 Dollars (\$50,000.00)** for faithful performance of the services to be rendered under this Agreement, subject to the additional Fee Schedule provisions of Section 4."

Section 4. - CONSULTANT'S PROPOSAL - is amended as follows:

"The City shall pay Consultant for those additional services set forth in Consultant's proposal, attached hereto as Exhibit A-1 and hereby incorporated as part of this agreement by this reference."

Section 6. - TERM OF AGREEMENT - is amended as follows:

"The City hereby amends the Term of Agreement to expire on June 30, 2022 (the "Termination Date")."

Except as amended herein, the terms and conditions of the Original Agreement and all previous amendments remain in full force and effect.
