**RESOLUTION NO. 22-110**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF VICTORVILLE AMENDING THE ANNUAL BUDGET FOR FISCAL YEAR 2022-2023; RELATING TO AN APPROPRIATIONS OF ADDITIONAL REVENUE**

**WHEREAS**, in 2006 the City of Victorville purchased Assessor Parcel Numbers (“APNs”) 3070-401-11, 3070-401-01 and 3070-401-02, more specifically described in Exhibit A (“Properties”), for the purposes of future park use; and

**WHEREAS**, the Properties are no longer considered necessary for the development of a park and therefore have been deemed “surplus” according to Government Code Sections 54220-54233 under the Surplus Property Land Act (“Act”); and

**WHEREAS**, Section 54221(f)(1)(D) of the Act defines “exempt surplus land” to include surplus land that is transferred to another local, state, or federal agency for this agency’s use; and

**WHEREAS**, the Mojave Water Agency (the “MWA”) has determined that the Properties meet the needs of the agency for the construction of a regional groundwater recharge facility and therefore desires to acquire the Properties from the City; and

**WHEREAS**, on March 15, 2022 the City adopted Resolution No. 22-016 declaring the Properties as exempt surplus as such sale and transfer qualifies under the Act Section 54221(f)(1)(D); and

**WHEREAS**, the City and the MWA have negotiated purchase and sale terms for the transfer of the Properties; and

**WHEREAS**, the City Manager, of the City of Victorville did heretofore submit to the City Council of the City of Victorville an estimate of the expenditures and revenues of the City for the fiscal year 2022-2023; and

**WHEREAS**, copies of said budget were prepared and distributed to the City Council and approved on June 21, 2022 and have been available for inspection by the public in the office of the City Clerk of the City of Victorville; and

**WHEREAS**, the sale of the Properties will generate sale proceeds in the approximate amount of Five Hundred Seventy-Five Thousand Dollars and 00/100 (\$575,000.00), less escrow and title fees; and

**WHEREAS**, a need to amend the budget is necessary to recognize the increase in budget revenue.

**NOW, THEREFORE, THE BOARD OF DIRECTORS OF THE VICTORVILLE WATER DISTRICT DOES HEREBY RESOLVE AS FOLLOWS:**

**SECTION 1.** That the annual budget for the fiscal year 2022-2023 for the City of Victorville be hereby amended to reflect an increase in budget revenue, as shown below and as described in the corresponding agenda item dated October 4, 2022.

**SECTION 2.** That copies of such amended budget, certified by the City Clerk, shall be filed with the auditors of the City of Victorville and in the office of the City Clerk for public inspection and certified copies thereof shall be made available for use by the City departments, offices and subsidiary of the City.

**SECTION 3.** This Resolution shall take effect immediately upon its adoption.
