THIS AMENDMENT (the "Amendment") is made and entered in to this ____ day of _____ 2023, by and between the Victorville Water District, a County Water District and subsidiary district of the City of Victorville, organized and existing in the County of San Bernardino under and by virtue of the laws of the State of California (hereinafter referred to as "District"), and **Univar Solutions USA, Inc., a State of Illinois corporation**, hereinafter referred to as "Service Provider." The District and the Service Provider are sometimes hereinafter referred to as a "Party" or and collectively referred to as the "Parties".

Recitals

1. **WHEREAS**, the District has a General Services Provider Standard Agreement (hereinafter referred to as "Original Agreement") with the Service Provider to provide **Annual Supply Agreement for Sodium Hypochlorite Water Treatment Chemicals, Project CC22-102**; and
2. **WHEREAS**, it is the desire of the Parties to issue Amendment One (1) to the Original Agreement to increase Section 3., Compensation by \$100,000, thereby revising the total annual not to exceed sum from \$216,587.84 to \$316,587.84; and
3. **NOW THEREFORE**, in consideration of the covenants, conditions, and promises contained herein and for such other good and valuable consideration, receipt of which is hereby acknowledged, the Parties are willing to amend the Original Agreement as stated below.

Contract Amendment

Section 3. – COMPENSATION – is amended as follows:

"The District shall pay a total annual sum not to exceed **Three Hundred Sixteen Thousand Five Hundred Eighty-seven and 84/100 Dollars (\$316,587.84)** for the services to be rendered by Service Provider pursuant to this Agreement, subject to the provisions of Section 4."

Except as amended herein, the terms and conditions of the Original Agreement and all previous amendments remain in full force and effect.
