Dear Mr. Gengler:

We have reviewed and processed your amendment request for the above-referenced project through Caltrans Division of Local Assistance (HQ DLA) and the Federal Highway Administration (FHWA). Effective 05/09/2023, the project authorizing document (E-76) was revised to reflect the request for additional CON funds.

The Project End Date (PED) has been established by your agency, concurred by HQ DLA and approved by FHWA. Any costs incurred after this date will not be eligible for federal reimbursement. Your agency is expected to monitor the progress of its projects and if the need arises, revise the PED to accurately reflect the amount of time needed to complete the project or phase of the project. If the PED is revised after the authorized PED has past, any costs incurred between the expiration of the authorized PED and the revised PED are ineligible for reimbursement. Revisions to the PED require Caltrans concurrence and FHWA approval.

Please be reminded of the invoice processing requirements and reimbursement process in Chapter 5 of the LAPM. Invoices for reimbursement cannot be submitted until after funds are encumbered via an executed Program Supplemental Agreement (PSA) and/or an executed Finance Letter. Additionally, per the Master Agreement, an invoice must be submitted at least every six months to avoid being classified as inactive.

- 12/03/2019 This sequence #5 is a request for additional funding for R/W to extend TCE contract and Support Cost.
- 01/06/2020 Sequence #5 is a request for additional right of way funding to complete the reimbursement for work performed on engineering and administration and the acquisition of parcels for the rehabilitation and widening of the Bear Valley Road overhead at the BNSF Railroad tracks using post-programmed National Highway Performance Program FAST (NHPP) funds approved by the Caltrans HQ HBP unit on 1/06/20 and to extend the project end date from 12/31/19 to 7/31/21. Federal funds remaining from previously-obligated funding for preliminary engineering lapsed under State Cooperative Work Agreement (CWA) regulations and are no longer available for invoicing. Right of way was certified on 4/11/18. Federal funding is now limited to an increased \$301,002 for all right of way activities with a maximum reimbursement ratio of 88.53%. Reimburse with additional Z001 NHPP funds now at 88.53% on a pro rata reimbursement basis up to the increased federal amounts shown for right of way engineering and administration and for acquisition. Br. No. 54C-0547.
- 05/13/2020 Sequence #6 is a request for construction and construction engineering funding to widen the Bear Valley Road overhead at the BNSF Railroad tracks in the City of Victorville using Highway Bridge Program (HBP) funds programmed for FY 21-22 in Amendment #15 approved on 11/25/18 to SCAG's 2019 FTIP and EPSP'd to FY 19-20 on 5/13/20. Federal HBP apportionments were set aside for obligation on 5/11/20. Funding for preliminary engineering and right of way were previously obligated. The NEPA determination approved on 12/10/14 was first re-validated on 4/06/16, on 7/20/18, and again on 5/14/20. The federal funds will be encumbered and made available for local agency reimbursement when the current right of way certification is updated. Federal funding is limited to \$5,540,111.68 for construction with a maximum reimbursement ratio of 88.53%. Reimburse with additional Z001 NHPP funds at 88.53% on a lump sum reimbursement basis up to the federal amounts shown for construction and construction engineering. Br. No. 54C-0547.
- 07/24/2020 Sequence #7 updates the project's right of way certification from 4/11/18. There are no other changes.
- 08/30/2021 Sequence #8 is for additional CON funds in FFY 18/19 HIP in the amount of \$2,117,110.08. An amended funding agreement with SBCTA was based on contract amounts.

The City needs to obligate only \$2,117,110.08 HIP funds now. The remaining will be funded by HBP funds as approved in the latest Exhibit 6-D which is hoped to be requested sometime in October.

Also 2021 FTIP Amend #4 did not include HBP funds; therefore, in this current RFA, we will only request HIP Funds programmed in the FTIP.

Victorville has retained the construction management firm.
