## **TERMINATION AND RELEASE OF DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS**

**PLEASE TAKE NOTICE THAT** the City of Victorville (the “City”), a Municipal Corporation, as Successor to the Housing Assets of the Victorville Redevelopment Agency, and the City’s Economic Development Department (“Economic Development”), are the sole beneficiaries of that certain Declaration of Covenants, Conditions, and Restrictions executed by Economic Development on April 23, 2008 and recorded on May 21, 2008 as Instrument No. 2008-0231664 in the Official Records of San Bernardino County, California (the “Affordable Housing Restrictions”), upon that certain real property identified in the Affordable Housing Restrictions and described in the attached Exhibit A (the “Property”).

Economic Development administers the Owner-Occupied Residential Rehabilitation Program (OOR), under which said Affordable Housing Restrictions were recorded. Pursuant to the terms of the Affordable Housing Restrictions, Economic Development shall execute a release of the encumbrances provided that the homeowner has repaid the OOR loan in full to Economic Development. As the preceding conditions have now been met, Economic Development hereby terminates the Affordable Housing Restrictions and forever releases the encumbrances of the Affordable Housing Restrictions from the Property.
