Recommendation:

That the City Council and Board of Directors ratify Commercial Demand Schedule No. 17 in the amount of \$7,788,819.51, covering Electronic Fund Transfers No. 333696 through 333901 and Warrant No. 789321 through 789435 for 02/17/2023 through 03/02/2023, per the adopted budget for Fiscal Year 2022-2023 for the period covering July 1, 2022 through June 30, 2023.

Fiscal Impact:

The total fiscal impact for FY22-23 in the amount of \$7,788,819.51 is authorized with this action. The attached report details the total funds paid to vendors.

Background:

Pursuant to the City's Municipal Code (2.24.080) the attached demands were presented by the departments, audited by the Finance Department and subsequent warrants/wire transfers were issued.
