**Recommendation:**

That the Honorable Victorville Water District Board of Directors:

- (1) Open and conduct the public hearing and receive testimony for the adoption of the proposed Resolution No. VWD 24-007;
- (2) Close the public hearing;
- (3) Adopt Resolution No. VWD 24-007 entitled, "A Resolution of the Victorville Water District, City of Victorville, adding delinquent non-paid charges to the annual taxes levied upon the property for which the charges are delinquent and unpaid"; and
- (4) Authorize the Director of Finance to execute the County Agreement for Collection of Special Taxes, Fees, and Assessments.

**Fiscal Impact:**

Nominal costs were incurred, estimated under \$700, from publishing required notices, which have been budgeted for in the current fiscal year.

- 4100545-52110, Water Customer Service Supplies (75%)
- 4260545-52110, Solid Waste Customer Service Supplies (25%)

Proposed Resolution No. VWD 24-007 will allow delinquent balances to be collected for Fiscal Year 2024-2025 assessed by the County Assessor; assessments to be submitted for an estimated total of \$115,970.

**Strategic Plan Goal:**

This item aligns with Goal A, Financial Sustainability – foster fiscal health through disciplined long-term planning, cost control, increased revenues, and cost recovery. By adding the non-paid charges to the taxes levied upon the property, the Victorville Water

District is able to collect expected revenues and help maintain water rates as low as possible.

**Discussion:**

Attached is a report of delinquent non-paid charges for water services within the Water District. The list includes the property location, assessor's parcel number (APN), amount of unpaid charges, and property owner. The property owners have been notified of their delinquency and of the public hearing. As of this date, the balances shown remain unpaid. Per California Water Code Section 31701(e) and 31701.5, accounts that are more than sixty days delinquent and have unpaid charges may be included in the property tax levied and shall constitute a lien on said property.

Notices of the Public Hearing and availability of the written report were mailed to all affected parcel owners on June 14, 2024, and published twice in the newspaper on June 14, 2024, and June 28, 2024. The notice mailed out to parcel owners provides them with an opportunity to remedy the arrearage on or before July 23, 2024, at 4 p.m. to avoid having the delinquent non-paid charges added to the annual taxes levied upon their property. Delinquent balances paid before the deadline will be removed from the list submitted to the County Assessor.

Staff remains available for any questions the Board of Directors may have.

## **RESOLUTION NO. VWD 24-007**

### **A RESOLUTION OF THE VICTORVILLE WATER DISTRICT, CITY OF VICTORVILLE, ADDING DELINQUENT NON-PAID CHARGES TO ANNUAL TAXES LEVIED UPON THE PROPERTY FOR WHICH THE CHARGES ARE DELINQUENT AND UNPAID**

**WHEREAS**, the Board of Directors of Victorville Water District has prepared a report and statement of those delinquent non-paid charges for water and other services within the District, which will be delinquent and unpaid for sixty days or more shall they remain unpaid as of July 23, 2024, done under and pursuant to Section 10.04.060 of the Victorville Municipal Code; and

**WHEREAS**, the Board has decided that said delinquent and unpaid charges are to be included in the property tax levied and shall constitute a lien on said property pursuant to California Water Code Sections 31701(e) and 31701.5 et seq; and

**WHEREAS**, after the filing of said assessment/lien, the City Clerk has, as required by law, given notice of the filing of said assessment and of the time fixed in said notice for hearing by this Board of Directors; and

**WHEREAS**, all property owners involved in this assessment/lien have been duly notified pursuant to California Water Code Section 31701.6; and

**WHEREAS**, a Public Hearing was held before the Board of Directors of the Victorville Water District, at 6:00 p.m., July 16, 2024, in the Victorville City Council Chambers, 14343 Civic Drive, Victorville, California, the time and place fixed in such notice; and

**WHEREAS**, during the aforementioned Public Hearing, all appeals, protests or objections, if any, were duly presented and all persons desiring to be heard thereon were heard and the Board of Directors gave all persons present an opportunity to be heard in respect to any matter relating to said work, to any act or determination of said Board of Directors in relation thereto, to the correctness of said assessment, or to any matter relating to said work, or the proceedings therefor; and

**WHEREAS**, all such persons desiring to be heard have been heard by the Board of Directors.

**THEREFORE, THE BOARD OF DIRECTORS OF VICTORVILLE WATER DISTRICT DOES HEREBY RESOLVE, DETERMINE, AND ORDER AS FOLLOWS:**

**SECTION 1.** That said hearing has been duly held; that each and every step in the proceedings prior to and including the hearing has been duly and regularly taken; that this Board of Directors is satisfied with the correctness of the assessment; the proceedings and all matters relating thereto; and that all protests, objections, or appeals be and the same are

hereby overruled and denied, and the Board of Directors does hereby confirm said proceedings and said assessment.

**SECTION 2.** That the report of the Victorville Water District's delinquent and unpaid charges for water and other services within the District, which remain unpaid and delinquent for sixty days or more as of July 23, 2024, is hereby adopted and approved by said Board.

**SECTION 3.** That the Secretary shall file with the County Auditor of the County of San Bernardino a copy of such written report with a statement endorsed hereon over the signature of the Secretary, that such a report has been adopted and approved by the Board of Directors and that the County Auditor shall enter the amount of such charges against the respective lots or parcels of land as they appear on the current assessment roll.

**SECTION 4.** That the amount of unpaid charges shall be added to the annual taxes next levied upon the property by the County Tax Collector, and that the amount of such charges shall constitute a lien on that property pursuant to California Water Code Section 31701.5, and that the amount of such unpaid and delinquent charges shall be collected at the same time and in the same manner, together with the general taxes, and shall be delinquent at the same time, and thereafter be subject to the same delinquency penalties.

**SECTION 5.** That all liens not paid within one year from the adoption of this resolution shall bear interest on the unpaid balance at the rate of ten percent (10%) per annum on the unpaid balance.

**SECTION 6.** That the parcels to be lien and the amount of said lien are set forth on Exhibit "A" attached hereto and made a part hereof. Unpaid balances will continue to be updated prior to submission as payments and/or charges are posted to the accounts.

## **ATTACHMENT B**

### **Water Code Sections 31701 and 31701.5**

## **WATER CODE**

### **Section 31701**

If a district has no revenue or if the revenues of the district are, or in the judgment of the board of directors are likely to be, inadequate to pay the interest on or principal of any bonded debt as it becomes due, or any other expenses or claims against the district, or if there are delinquent and unpaid charges, as defined in subdivision (e), outstanding, the board of directors shall, annually, on or before August 1st, furnish to the board of supervisors and to the auditor of each county, respectively, in writing:

(a) An estimate of the minimum amount of money required to be raised by taxes in the county for the payment of its proportion of the amount required to pay the principal of or interest on any bonded debt of the district or of an improvement district therein as it becomes due.

(b) A description of the improvement district benefited by the purposes of the bonded debt as stated in the resolution declaring the necessity to incur the bonded indebtedness, or, if the whole district was benefited by incurring it, a statement of that fact.

(c) An estimate of the minimum amount of money required to be raised by taxes in the county for the payment of its proportion of the amount required to meet all the charges, claims, expenditures and expenses, other than a bonded debt, of each improvement district created in the county pursuant to this division, together with a description of each such improvement district as determined by resolution of the board.

(d) An estimate of the minimum amount of money required to be raised by taxes in the county for the payment of its proportion of the amount required by the district for other expenses and claims against it.

(e) A statement of those delinquent and unpaid charges for water and other services, or either, requested in writing by the owner of the property that remain delinquent and unpaid for 60 days or more on July 1st determined by the board to be included therein.

(f) The estimate of the minimum amount of money required to be raised by taxes in the county under subdivisions (c) and (d) shall not exceed the amounts permitted by any maximum property tax rate limitation in the Revenue and Taxation Code, provided however, that if no tax was levied by the district for either the 1971–1972 or the 1972–1973 fiscal year and the district incurred expenses in such years which expenses were paid from revenues other than taxes, then the maximum levy shall not exceed fifty cents (\$0.50) per one hundred dollars (\$100) of assessed valuation per year.

### **Section 31701.5**

The amount of any charges for water and other services or either included in the statement of delinquent and unpaid charges pursuant to subdivision (e) of Section 31701

shall be added to and become a part of the annual taxes next levied upon the property upon which the water for which the charges are unpaid was used and upon the property subject to the charges for any other district services and shall constitute a lien on that property as of the same time and in the same manner as does the tax lien securing such annual taxes. All laws applicable to the levy, collection and enforcement of municipal ad valorem taxes shall be applicable to such charges, except that if any real property to which such lien would attach has been transferred or conveyed to a bona fide purchaser for value, or if a lien of a bona fide encumbrancer for value has been created and attaches thereon, prior to the date on which the first installment of such taxes would become delinquent, then the lien which would otherwise be imposed by this section shall not attach to such real property and the delinquent and unpaid charges relating to such property shall be transferred to the unsecured roll for collection. The county shall deduct from the charges collected an amount sufficient to compensate the county for costs incurred in collecting such delinquent and unpaid charges. The amount of such compensation shall be fixed by agreement between the board of supervisors and the district's board of directors.
