Recommendation:

That the Honorable City Council:

- 1) Open and conduct the public hearing and receive testimony for the adoption of the proposed Resolution No. 24-071;
- 2) Close the public hearing;
- 3) Adopt Resolution No. 24-071 entitled, "A Resolution of the City Council of Victorville, California, making determination and confirming assessments and proceedings for Unpaid Rubbish Collection, Sewer Use Fees, Storm Drain Fees, Hazardous Waste Fees, and/or Assembly Bill 939 Recycling Fees; and
- 4) Authorize the Director of Finance to execute the County Agreement for Collection of Special Taxes, Fees, and Assessments.

Fiscal Impact:

Nominal costs were incurred, estimated under \$700, from publishing required notices, which have been budgeted for in the current fiscal year.

- 4100545-52110, Water Customer Service Supplies (75%)
- 4260545-52110, Solid Waste Customer Service Supplies (25%)

Proposed Resolution No. 24-071 will allow delinquent balances to be collected for Fiscal Year 2024-2025 assessed by the County Assessor; assessments to be submitted for an estimated total of \$176,580.

Strategic Plan Goal:

This item aligns with Goal A. Financial Sustainability – foster fiscal health through disciplined long-term planning, cost control, increased revenues, and cost recovery. By

adding the non-paid fees to the taxes levied upon the property, the City is able to collect expected revenues and help maintain rates as low as possible.

Discussion:

Exhibit A to Resolution No. 24-071 includes a list of property owners delinquent in their rubbish collection fees, sewer use fees, storm drain fees, hazardous waste fees, and/or Assembly Bill 939 recycling fees. As of this date, the balances shown remain unpaid. Per Victorville Municipal Code Section 6.36.085, this list is comprised of accounts that are more than sixty days past due and are submitted to confirm liens on the properties, which shall be included on the tax roll for taxes levied against the said properties.

Notices of Public Hearing and availability of the written report were mailed to all affected parcel owners on June 14, 2024, and published twice in the newspaper on June 14, 2024, and June 28, 2024. The notice mailed out to owners provides them with an opportunity to remedy the arrearage on or before July 23, 2024, at 4 p.m. to avoid having the delinquent non-paid charges added to the annual tax levied upon the property. Delinquent balances paid before the deadline will be removed from the list submitted to the County Assessor.

Staff remains available for any questions the Council may have.

Resolution No. 24-071

RESOLUTION NO. 24-071

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF VICTORVILLE, CALIFORNIA, MAKING DETERMINATION AND CONFIRMING ASSESSMENTS AND PROCEEDINGS FOR UNPAID RUBBISH COLLECTION, SEWER USE FEES, STORM DRAIN FEES, HAZARDOUS WASTE FEES AND/OR ASSEMBLY BILL 939 RECYCLING FEES

WHEREAS, the City Council of the City of Victorville, California, has here before filed in the office of the City Clerk of said City, a report and statement of certain delinquent unpaid rubbish collection, sewer use fees, storm drain fees, hazardous waste fees and/or Assembly Bill 939 recycling fees in said City, which will be delinquent and unpaid for sixty days or more and shall they remain unpaid as of July 23, 2024, done under and pursuant to Section 6.36.085 of the Victorville Municipal Code; and

WHEREAS, the Board has decided that said delinquent and unpaid charges are to be included in the property tax levied and shall constitute a lien on said property pursuant to California Health and Safety Code Section 6520.10 et seq; and

WHEREAS, after the filing of said assessment/lien, the City Clerk has, as required by law, given notice of the filing of said assessment and of the time fixed in said notice for hearing by this City Council; and

WHEREAS, all property owners involved in this assessment/lien have been duly notified pursuant to California Health and Safety Code Section 6520.11; and

WHEREAS, a Public Hearing was held before the City Council of the City of Victorville at 6:00 p.m., July 16, 2024 in the City Council Chambers, 14343 Civic Drive, Victorville, California, the time and place fixed in such notice; and

WHEREAS, during the aforementioned Public Hearing, all appeals, protests or objections, if any, were duly presented and all persons desiring to be heard thereon were heard and the City Council gave all persons present an opportunity to be heard in respect to any matter relating to said work, to any act or determination of the City Council of said City in relation thereto, to the correctness of said assessment, or to any matter relating to said work, or the proceedings therefore; and

WHEREAS, all such persons desiring to be heard have been heard by the City Council and are fully informed in the premises.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF VICTORVILLE DOES HEREBY FIND, DETERMINE AND ORDER AS FOLLOWS:

SECTION 1. That said hearing has been duly held; that each and every step in the proceedings prior to and including the hearing has been duly and regularly taken; that this

City Council is satisfied with the correctness of the assessment; the proceedings and all matters relating thereto; and that all protests, objections, or appeals be and the same are hereby overruled and denied, and the City Council does hereby confirm said proceedings and said assessment.

SECTION 2. That the report of the City of Victorville's delinquent and unpaid charges for sanitation and other services within the District, which remain unpaid and delinquent for sixty days or more as of July 23, 2024, is hereby adopted and approved by said Board.

SECTION 3. That the Secretary shall file with the County Auditor of the County of San Bernardino a copy of such written report with a statement endorsed hereon over the signature of the Secretary, that such a report has been adopted and approved by the City Council and that the County Auditor shall enter the amount of such charges against the respective lots or parcels of land as they appear on the current assessment roll.

SECTION 4. That the amount of unpaid charges shall be added to the annual taxes next levied upon the property by the County Tax Collector, and that the amount of such charges shall constitute a lien on that property pursuant to California Health and Safety Code Section 6520.10, and that the amount of such unpaid and delinquent charges shall be collected at the same time and in the same manner, together with the general taxes, and shall be delinquent at the same time, and thereafter be subject to the same delinquency penalties.

SECTION 5. That all liens not paid within one year from the adoption of this resolution shall bear interest on the unpaid balance at the rate of ten percent (10%) per annum on the unpaid balance.

SECTION 6. That the parcels to be liened and the amount of said lien are set forth on Exhibit "A" attached hereto and made a part hereof. Unpaid balances will continue to be updated prior to submission as payments and/or charges are posted to the accounts.

ATTACHMENT B

Victorville Municipal Code 6.36.085

California Health and Safety Code Sections 6520.10 and 6520.11

VICTORVILLE MUNICIPAL CODE

Section 6.36.085

Collection procedure for delinquent accounts—Creation of lien.

- (a) The furnishing of collection services to customers of the city's solid waste system shall be subject to the provisions of this chapter and the rules and regulations.
- (b) Any fees authorized by this chapter, the balance of which remain unpaid and delinquent for sixty days or more, will become a lien against the premises to which such services are rendered, in accordance with the following procedure:
 - (1) The city council shall cause a report of delinquent fees for collection services to be prepared periodically, but in no event less than once a year. The city council shall fix a time, date and place for hearing the report and any objections or protests thereto.
 - (2) The city council shall cause notice of the hearing to be mailed to the landowners (owners of premises) listed on the report not less than fifteen days prior to the date of the hearing.
 - (3) At the hearing, the city council shall hear any objections or protests of landowners liable to be assessed for delinquent fees. The city council may make such revisions or corrections to the report as it deems just, after which, by resolution, the report shall be confirmed.
 - (4) The delinquent fees set forth in the report as confirmed shall constitute special assessments against the respective parcels of land and are a lien on the premises for the amount of such delinquent fees, including such late charges and cost of lien as are set forth in the report as confirmed.
 - (5) A certified copy of the confirmed report shall be filed with the city clerk, or auditor appointed by the city council, for the amounts of the respective assessments against the respective parcels of land as they appear on the current assessment roll. The lien created attaches upon recordation, in the office of the county recorder, of a certified copy of the resolution of confirmation. The assessment may be collected at the same time and in the same manner as other property taxes and liens are collected and shall be subject to the same penalties and the same procedure and sale in case of delinquency as provided for such taxes. All laws applicable to the levy, collection and enforcement of city ad valorem property taxes shall be applicable to such assessment.

HEALTH AND SAFETY CODE

Section 6520.10

On or before August 10, the board may certify to the board of supervisors and county auditor a statement of any delinquent and unpaid charges for sewer and other services, or either, requested in writing by the owner of the property that remain delinquent and

unpaid for a period of 60 days or more on July 1. The amount of any charges for sewer and other services, or either, included in the statement of delinquent and unpaid charges shall be added to and become a part of the annual taxes next levied upon the property for which the sewer service was provided and upon the property subject to the charges for any other district services and shall constitute a lien on that property as of the same time and in the same manner as does the tax lien securing the annual taxes. All laws applicable to the levy, collection, and enforcement of ad valorem taxes shall be applicable to the charges, except that if any real property to which the lien would attach has been transferred or conveyed to a bona fide purchaser for value, or if a lien of a bona fide encumbrancer for value has been created and attaches thereon prior to the date on which the first installment of the taxes would become delinquent, then the lien which would otherwise be imposed by this section shall not attach to the real property and the charges relating to the property shall be transferred to the unsecured roll for collection. The county shall deduct from the charges collected an amount sufficient to compensate the county for costs incurred in collecting the delinquent and unpaid charges. The amount of the compensation shall be fixed by agreement between the board of supervisors and the district's board of directors.

Section 6520.11

A district shall notify the assessee shown on the latest equalized assessment roll whenever delinquent and unpaid charges for sewer and other services, or either, which could become a lien on the property pursuant to Section 6520.10 remain delinquent and unpaid for 60 days.
